1. Elizabeth Thiel – Financial

The meeting was called to order at 7:00 PM by RE Charlie Tanck

Members and guests attending: approximately 25.

Charlie Tanck – RE

- The meeting began with an explanation about how it happened that the region sent 2 applications to National Office for a Grant. There was 1 grant per region awarded.
 - Track Day received the grant, Autocross did not.
 - Autocross was guaranteed the grant by Howard Duncan.
 - These are Track Night in America Grants, so it is felt that the experiential program, i.e. Track days received the grant as that is now the focus of TNIA and the National Office.
 - Discussion ensued.
 - The decision makers were unknown to the FLR Autocross leadership when they called
 - General feeling is that it was not Charlie's fault.
 - Charlie requested that they apply again. It is not cast in stone that it will automatically go to the Track Days, although that is the feeling from the Autocrossers in the room.
